ART. 1: ORGANIZATION

The Association “ Manlio Selis “ World Tournament, organizes an international tournament Entitled **24th “Manlio Selis” World Tournament** ,in collaboration with *Sardinia Regional Council, the Municipalities of Olbia, San Teodoro, Calangianus and Tempio Pausania.*

The tournament will take place from 27th December to th 30 December 2021 in the pitches of *Olbia, San Teodoro, Calangianus and Tempio Pausania.*

ART. 2: CATEGORY OF PARTICIPATION AND AGE LIMITS

The tournament is addressed to young soccer players who are regularly enrolled with their own club and federation for the season in progress. They have to be born from **01.01.2008 to 31.12.2008.**

It is possible to use a maximum of 5 players born in 2009 who, on the date of the tournament, have completed their twelfth year of age.

ART. 3: LOANS

Loans may be used up to a maximum of 3 (THREE) per team that are not interchangeable and valid for the entire duration of the tournament, subject to the presentation of a regular authorization issued by the company to which they belong, which cannot be among the participants in the tournament.

ART. 4: FOOTBALL PLAYERS LIST

Loans may be used up to a maximum of 3 (THREE) per team that are not interchangeable and valid for the entire duration of the tournament, subject to the presentation of a regular authorization issued by the company to which they belong, which cannot be among the participants in the tournament.

A list of players eligible to participate shall be forwarded to the organizer committee before the start of the tournament. Lists shall comprise a maximum of 18 players (for professional clubs) and 21 players for amateur clubs) plus staff and will include: name, surname, date of birth, Football Federation card number, shirt number. Please be aware that the shirt number will have to be the same for the whole Tournament.

The list of players for team, which shall be given to the referee, is limited to players.

ART. 5: SUBSTITUTIONS

There are no 7 replacement, independently from the role, at any time of the race.

ART. 6: PARTICIPATING TEAMS

ART. 7 TOURNAMENT FORMULA

The "Manlio Selis" "will take place according to the following formula:

A) FIRST PHASE

The 24 teams will be divided into 6 groups made up of 4 teams.

The top seeds will be appointed at the discretion of the organizing company.

The teams will meet in one-way matches lasting 40 minutes (2 halves of 20 minutes each).

The matches are played 11 against 11 on regular-sized fields with regulation goals and the use of n ° 5 balls.

The rankings will be drawn up on the basis of the following criteria:

3 (three) points for each match won

1 (one) point for each match ended in a draw

0 (zero) points for defeat

In the event of a tie, the criteria listed below apply:

1. Outcome of direct meetings
2. Goal difference in direct matches between teams with equal points
3. Goal difference in the total number of matches played in the Group
4. Highest number of goals scored out of the total number of matches played in the Group
5. Draw, which will be carried out by the Association " World Tournament Manlio Selis " in the presence of the representatives of the teams concerned.

The first team classified in each group will be admitted to the next phase (Quarter-finals) plus the best two second.

B) Second Phase

Direct elimination phases

The teams will play only one game lasting 2 times of 25 minutes, with direct elimination. In case of draw at the end of the regular times, penalties will be hit following Rule n. 7 and referees' official decisions.

Quarter finals.

The teams will play only one game lasting 2 times of 25 minutes, with direct elimination. In case of draw at the end of the regular times, penalties will be hit following Rule n. 7 and referees' official decisions

Semi-finals.

The winning teams in the quarterfinals will play the games in the semi-finals following the same rules as in the quarterfinals.

Final

The winners of the two semi-finals will play the final game, which will last 2 times of 25 minutes each. In case of draw after the two regular times, two extra times of 10 minutes each will be played. If, at the end of the second extra time, the result is still a draw, penalties will be hit following the rules of the previous phases.

ART. 8 RANKING

The ranking will be drawn up in light of the following criteria: 3 points for win -1 point for draw -0 points for defeat.

In case of equal points the criteria below listed apply:

1. Outcome of direct games.
2. Difference in score in direct games between the teams having equal points.
3. Difference in score out of the total of matches played in the round.
4. Highest number of goals scored out of the total of games played in round
5. Drawing.

ART. 9 PLAYING TIMES

The matches will last 2 (two) times of 20 minutes each. Matches are played 11> 11 regular football field with regular door and balls number 5.

ART. 10 PENALTIES. (To be applied in Finals, Semi-finals or direct elimination matches)

In case of draw at the end of the regular times, penalties will be hit following Rule n. 7 and referees' official decisions.

ART. 11. EXTRA TIME.

Only for finals for 1st and 2nd place. In case of draw after the two regular times, two extra times of 10 minutes each will be played. If, at the end of the second extra time, the result is still a draw, penalties will be hit following the rules in Art. 10.

ART. 12 REFEREES

The matches will be directed by referees accredited by F.I.G.C. / A.I.A.

ART. 13 TOURNAMENT COMMITTEE

The committee of the tournament will be responsible for any discussion, protest, complaint or unexpected circumstances. The committee will be composed by the following persons:

CHAIRMAN	Enea Selis

The committee will not accept complaints or claims about the decisions of the referees. If necessary, the committee will report players or members of the participating teams considered to have a non-sportive behavior. These reports will be sent to the national or international federations who are responsible of taking formal measures.

ART. 14 DISCIPLINE OF THE TOURNAMENT

The discipline in the tournament is guaranteed by the sports judge in charge or the substitute in the competent committee.

ART. 15 IMMEDIACY OF SANCTIONS

The article 45, paragraph 2 of the sports' justice does not provide any automatism in the sanctions for the category "Under 14"; this will be, therefore, subjected to the sports judge's decisions.

ART. 16 COMPLAINTS

All protests or complaints shall be made to the tournament committee, whose decision shall be final and binding. The complaints have to be forwarded within 30 minutes from the end of the match after the payment of a fee of € 100, 00. As well as a copy of the claim has to be handed out to the counterpart within 30 minutes from the end of the match. The committee will not accept protests or complaints relating to decisions taken by the referee.

ART. 17 INSURANCE

Each participating club has the responsibility to provide insurance cover to its own players. The tournament organization is responsible of the reliability of the insurance cover.

ART. 18 I.F.A.B.

The matches are played following the current rules of the *International Football Associations Board* (I.F.A.B.).

ART. 19 GENERAL RULES

As regards anything not specifically provided by this regulations, Federal regulations are valid as well as the ones reported on the Official Statement n.1 for Youth and School sector, related to the current sports year.
